





During a Sept. 20 bond hearing, Judge Brett Martin denied the prosecution's request to increase bond for Prieto, who posted \$2,000 bond and was released from the Adams County Detention Center a couple days after the original incident on Aug. 29. According to the judge, current bond was thought to be appropriate but he also left open the possibility for increasing bond and putting Prieto back in jail if circumstances changed.

"So at this time, I'm finding that does meet the needs for the community safety, Mr. Prieto," Martin said, according to the Sept. 20 court hearing transcript. "But you have to understand, if you miss any court dates or you're not compliant with [the State Review Panel], then I am looking at what the standard customary bond for a class-two felony would be, \$50,000, and that's kind of going to be my starting point if there are issues."

During the bond increase debate, prosecutor Michael Perez agreed that Prieto was first approached by an adversarial juvenile acquaintance before the incident occurred, but that the actions that followed were felonious in nature.

"Your honor, I do admit that there [are] some possible defenses in the by itself is pretty outrageous."

Prieto reportedly fired four rounds from a firearm at a vehicle that was occupied by not only the juvenile acquaintance but three

"This happened to take place next to kind of like a soccer training complex with a bunch of kids and parents," Perez argued. "Multiple eyewitnesses saw the defendant pointing the gun at the vehicle and start shooting.

"When apprehended, Mr. Prieto was on the phone with his father. He said, Dad, I'm going to jail; I just shot two people. This area, like I said, was catty-corner from a youth soccer field complex where a kids' soccer game was taking place. Many individuals at the game were concerned for their own safety."

The public defender representing Prieto argued that her client

has taken all the steps required in the legal process so far and that the original charge suggested by the Adams County Sheriff's office is more appropriate to the situation.

"[A] vehicle with four individuals drove up along Mr. Prieto as he was just walking on the side of the road," the defense counsel said. "He had done nothing to engage with this car. They saw him, sought him out. And the individuals in the car all admit that [the juvenile occupant] was the one who first started yelling out of the car and harassing Mr. Prieto.

"Menacing is, at most, I think, what happened here."

Defense counsel also indicated that Prieto has significant family ties to the area that would minimize the flight chances and that, with the exception of some contact with Texas law enforcement as a juvenile, he has not had "a significant criminal history."

"Ultimately no convictions were had," she said.

A man claiming to be Prieto's father in multiple phone messages to *The I-70 Scout* after the September bond hearing added that his son's actions were a reaction to longtime threats from the juvenile aggressor mentioned during the court proceedings.

"Pure case of self defense," Jose this particular case," Perez said. Medina said. "You don't know "However, I do believe the conduct—about this kid ... a total terror, Death threats against us for months."

But following the Sept. 20 bond hearing, Prieto was booked back into the Adams County Detention Center on Oct. 7 on separate charges of fifth-degree felony menacing with a real or simulated weapon, first-degree misdemeanor child abuse, and violation of a pro-

According to the Adams County Sheriff's Office, as of Oct. 27, Prieto remained in custody on \$10,000



Tuna Pasta Salad

This tuna salad is one example of a salad without lettuce. Water-based tuna is recommended but I prefer oily tuna because it seems to have more flavor. Whichever you use, thoroughly drain it.

Homemade mayonnaise dressing is easy to make but bottled dressing is even easier.

Cole slaw dressing has all of the needed ingredients.

I sometimes make Tuna Pasta Salad with rainbow rotini pasta and add cubed white cheese.

If you need lettuce to call it a salad, line your bowl with lettuce!

INGREDIENTS

1 (12-ounce) package white rotini pasta

½ cup chopped celery 3 green onions, sliced

1 cup coleslaw dressing

1 (6-ounce) can tuna, drained

1/2 cup frozen baby peas 1/2 cup diced cheddar cheese



salt and pepper to taste ½ teaspoon dried dill

DIRECTIONS

Boil pasta to al dente in salted water. Drain and rinse.

In a pretty salad bowl, mix celery, onions and cole slaw dressing. Stir in drained tuna, peas and cheese. Fold in the cooked pasta.

Sprinkle with salt, pepper, and dill.

Gently toss. Refrigerate covered at least 1 hour to chill.

Serve with crackers.
